MINUTES OF THE MEETING HELD ON 24th JULY 2024 200/24

> The minutes of the meeting on the 24th July 2024 which were circulated on 6th August 2024 and received at the Full Council meeting on 16th September

201/24 FUTURE USE OF ST LEONARD'S MOUND, RICHINGS PARK

> The Deputy Clerk reported that discussions were still on-going with the community and Nursery regarding this area and the opportunities for it. Work had started to re-build the steps by the Grounds Maintenance team and this would continue once the team were fully resourced again after the taking of Annual Leave. Cllr Matthews had arranged to meet the Heathrow Rangers with the Deputy Clerk to agree their support in the development of the area.

CCTV COVERAGE OF RECREATION GROUNDS 202/24

> The Deputy Clerk reported that he & the Deputy Clerk for Facilities and Events had met with the current CCTV contractor to assess the possibilities needed to extend the coverage of the current CCTV cameras. This would be referred back to the Facilities and Events Committee. He also highlighted that the Locum Clerk had highlighted some significant requirements regarding data protection and that a DPO / Impact assessment would need to be carried out.

203/24 **DEVOLVED SERVICE – GRASS VERGE CUTTING WORKING GROUP**

> The notes of the previous Working Group meetings were received. Cllr Brown talked to the notes and further discussion took place covering the following matters:

- More worked would be needed by officers to look at contract details and seek further clarification
- Concerns were raised about the accuracy of the information from the Devolved Services team at Bucks
- A possibility of deferring any discussion and further work until a permanent Clerk is in post
- A question was raised as to whether a feasibility study into this was required by law
- A need for full information to be available before communicating with the public
- The need to be in a strong position to be sure that there won't be a call back on any money paid to the Council by Bucks

Officers to take the matter to contract negotiation stage and to work with the Working Group to resolve any further details as needed and engage legal representation of needed and bring back to this committee. It was noted that Officers are not to enter into the Contract. This was seconded by Cllr Peter Stanhope.

To look into a feasibility study based on the recommendation of the Working Group once a permanent Clerk is in post. This was seconded by Cllr Hutchings.

The motion was therefore carried.

The following was raised by Cllr Kinchin: That the Working Group be discontinued.

For: Cllr Hutchins, Beary, Kinchin & Matthews (4) **Against:** Cllrs Cook, Rossetti & Stanhope (3)

Abstention: Cllrs Brown & Burke (2)

The motion was therefore carried.

Cllr Brown was thanked for chairing the Working Group.

The Deputy Clerk reported that the process for bringing a draft Open Spaces & Highways Income & Expenditure Budget to the November Committee Meeting was well underway.

The Deputy Clerk gave a verbal update which included the following:
