The Wexham Neighbourhood Plan is being prepared by Wexham Parish Council. We have reached an important milestone in the process having finalised the draft version of the document and I am writing to invite your views on the proposals contained within the it.

The consultation will run from Monday 16 December 2024 to Friday 15 February 2025.

This is a statutory Pre-Submission Consultation in accordance with the requirements of the Localism Act 2011 and Regulation 14 of the Neighbourhood Planning (General) Regulations 2012 (as amended).

The Wexham Neighbourhood Plan contains planning and land-use policies that, one 'made', would set out how land should be considered in the parish, in planning terms. They would also be a material planning consideration in the determination of planning applications, alongside the policies of the adopted South Bucks Local Plan and Core Strategy, until such a time when the new Buckinghamshire Council Local Plan is adopted, which would replace these.

A Steering Committee comprising local councillors and volunteers from the community was set up to lead the project on behalf of the Parish Council. A great deal of work has been undertaken to reach the point of having a draft Plan, which we are now consulting on. The Neighbourhood Plan must undergo a rigorous process, including a series of consultations, an independent examination and finally a local referendum.
