**279/24** The Chair of the Committee updated on the Committee on recent communications

from JSM Consulting regarding the previously proposed work at the Longbridge Mud Wharf (River Colne), Slough Road, Iver Heath. He advised that the Clerk and officers are now involved, and the Deputy Clerk advised an item concerning this had been placed on Full Council agenda for 16<sup>th</sup> December 2024 where the matter

can be discussed and any motions regarding previous resolution concerning this can be identified.

- Item 7: Draft Open Spaces & Highways Budget 2025/26
  - 7.1 Draft Open Spaces & Highways Income Budget 2025/26
- The Committee considered the Draft Income budget presented by the Deputy Clerk and agreed to recommend the budget of £9,762 to the Full Council Meeting on 16<sup>th</sup> December 2024.
  - 7.2 Draft Open Spaces & Highways Expenditure Budget 2025/26
- The Committee considered the Draft Income budget presented by the Deputy Clerk and after discussion concerning the conservation work carried out by Groundwork agreed an increase of £3.5k on the following three budget lines:
  - 8532/1 General Maintenance Iver Recreation Ground (Allotments site)
  - 8532/7 General Maintenance Swan Meadow
  - 8532/8 General Maintenance Harding's Row

It was agreed to recommend the budget of £142,000 to the Full Council Meeting on 16<sup>th</sup> December 2024.

- Item 8: Deputy Clerks Report
- The Deputy Clerk's Report was received and Cllr Matthews provided an update concerning the provision of support from the Heathrow Rangers with the project to re-open St Leonard's Mound as a facility for general use. The Heathrow Rangers have selected 4 projects to work on in 2025 and the development of St Leonard's Mound is one of these. This will enable them to give significant support as the Parish Council re-opens and develops the area for community use.

- The Deputy Clerk reported that in the handover between the Locum Clerk and the new permanent Clerk the requirement for a communication regarding the decision around Devolved Services had been missed and the Deputy Clerk would work with the new Clerk to produce this communication.
